This Statement of Privacy applies to the Global Bridge website and governs data collection and usage. By using the Global Bridge website, you consent to the data practices described in this statement.

Collection of your Personal Information

Global Bridge collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Global Bridge also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests, and favorites.

There is also information about your computer hardware and software that is automatically collected by Global Bridge. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Global Bridge for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Global Bridge Web site.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Global Bridge public message boards, this information may be collected and used by others. Note: Global Bridge does not read any of your private online communications.

Use of your Personal Information

Global Bridge collects and uses your personal information to operate the Global Bridge Web site and deliver the services you have requested. Global Bridge also uses your personally identifiable information to inform you of other products or services available from Global Bridge and its affiliates. Global Bridge may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Global Bridge does not sell, rent or lease its customer lists to third parties. Global Bridge may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Global Bridge may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Global Bridge, and they are required to maintain the confidentiality of your information.

Global Bridge does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Global Bridge keeps track of the Web sites and pages our customers visit within Global Bridge, in order to determine what Global Bridge services are the most popular. This data is used to deliver customized content and advertising within Global Bridge to customers whose behavior indicates that they are interested in a subject area.

Global Bridge Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply

with legal process served on Global Bridge or the site; (b) protect and defend the rights or property of Global Bridge ; and, (c) act under exigent circumstances to protect the personal safety of users of Global Bridge , or the public.

Use of Cookies

The Global Bridge Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Global Bridge pages, or register with Global Bridge site or services, a cookie helps Global Bridge to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Global Bridge Web site, the information you previously provided can be retrieved, so you can easily use the Global Bridge features that you customized.

Security of your Personal Information

Global Bridge secures your personal information from unauthorized access, use or disclosure. Global Bridge secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other Web sites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.
